

CERTIFICATE OF GUARANTEE

GUARANTEE APPLICATION CONDITIONS

GUARANTEE RULES

DURATION

In the presence of flaws or defects for which manufacturer liability is ascertained, EMEC s.r.l. guarantees the product for up to 2 (two) years from the date of purchase by the end Customer (hereinafter Customer). This shall be proved by a document issued by the authorized reseller, valid for all tax purposes.

For **Dosing Pumps and Control Instruments**, in the presence of flaws or defects for which manufacturer liability is ascertained, EMEC s.r.l. guarantees the product for up to **5 (five) years*** from the date of purchase by the end Customer (hereinafter Customer). This shall be proved by a document issued by the authorized reseller, valid for all tax purposes.

Any repair or replacement interventions extend the duration of the original warranty for 1 (one) year from the date of the last intervention, only on the replaced or repaired component.

VALIDITY

By guarantee it is intended free repairs or replacement of equipment parts which prove to be defective at source due to manufacturing defects; excluding the hypotheses indicated in the paragraph "Limits to liability". The right to the guarantee shall be proved by the original certificate or by a document valid for tax purposes, issued by the reseller at the time of purchase. Said documents must show model, product serial number, date of purchase. This commercial guarantee offered by EMEC does not prejudice consumer rights established by Legislative Decree no. 24, 2 February 2002, issued in application of European Directive 99/44/EC.

RESPONSIBILITIES OF EMEC srl

During the guarantee period, EMEC undertakes to correct any defects caused by manufacturing flaws, at no expense to the Customer.

In all cases EMEC hereby points out the equipment must be installed in an easily accessible place, in compliance with laws in force. If this should not be the case, expenses accrued to rent scaffolding, scaffolds, cranes or anything else needed to reach the unit in question shall be entirely at the Customer's expense. If the equipment cannot be repaired and/or if said repairs should be excessively expensive compared to product value, assessed under the manufacturer's unquestionable judgement, EMEC undertakes to replace the equipment for the end Customer with prior written notice, leaving original agreement expiry date and guarantee terms unchanged; proven by the tax document issued by the reseller at the time of purchase.

If the equipment should be replaced and if the same model as the one being replaced should not be available for any reason, EMEC reserves the right to replace the equipment with a similar type, but a different model, with the same functions and purpose.

LIMITS TO LIABILITY

Defects cannot be attributable to EMEC if Technical Personnel should ascertain that they have been caused by conditions that do not concern product operations.

The guarantee also excludes any intervention to replace parts subject to wear and/or removable; unless their breakage and/or malfunctioning is due to original defects.

The guarantee also excludes any jobs carried out by parties who do not have the specific technical preparation.

It is understood that EMEC declines all liability for installation carried out directly by the Customer, by the seller or under its responsibility.

SETTLING DISPUTES

Rieti Court of law shall have exclusive jurisdiction over any dispute arising from or due to executing this agreement.
